*Financial Process Information:

1. General Fund

- Approvers: WEST Board
- Funding requests and Board directed expenditures up to $\$ 600$ can be approved OR rejected by a majority of the WEST Board. Any expense over $\$ 600$ (except for field trips) must be presented at a WEST meeting and a majority vote is required to approve the funding. Any expense of $\$ 200$ or less can be decided by the WEST President(s) and one other board member with the approval of the treasurer.

2. Site Based Account Funds

- Approvers: WPS and CRS Principals
- Money that resides in the Site Based accounts has been primarily earned outside of WEST and is to be utilized at the sole discretion of the Principal overseeing the fund. Documentation is required strictly for auditing purposes. No WEST board member approval is required on these expenditures.

3. Community Fund

- Requestor/Approver: School Social Worker
- Income from community service fundraisers (if held) and donation from WEST General Fund, minimum $\$ 500$ per year.
- Expenses include gift cards and other items at the discretion of the school social worker to help students and families in need.


## New Business Discussed

1. Request from various organizations such as Cub Scout sign-ups and Geddes Little League to post information \& sign ups on WEST Facebook page denied. WEST Facebook page is strictly to communicate WEST events and activities to CRS and WPS community.
2. WEST Format: Discussion on the possibility of exploring new ways for the WEST parent organization to be formatted. This includes the exploration and
discussion with Superintendent/Principals on formalizing a PTA. Discussion by some WEST board members to be more involved in CRS/WPS community by organizing presentations and speakers to help families with supportive resources and advocacy with issues such as bullying (for example).
